2. Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(a) **Single stage – single envelope** procedure.
3. Bids may be submitted as per conditions set out in bidding documents electronically through federal PPRA EPADS web portal <http://eprocare.gov.pk> before closing time & date. Manual bids shall not be accepted. Supporting documents can be sent in hard copy. The bids shall be opened on the same day at 11:30 AM.
4. Scanned copy of **Bid Security @ 5% of total quoted value (incl. all taxes)** in the shape of deposit at call or a bank guarantee issued by a scheduled bank in the name of Director General PITAC, Lahore be sent through EPADS, while the original Bid Security along with supporting documents must be dispatched to the undersigned. Bid, without earnest money or cross cheque will be rejected.
5. The bids shall be inclusive of all applicable taxes.
6. The bids of any bidder shall be declared non-responsive, if he is found involved in litigation with any government or semi-government department.
7. The successful bidder will be responsible to supply the items at PITAC Stores Section at their own expenses.
8. In case of any dispute regarding the terms & conditions and quality of items, decision of Competent Authority i.e. Director General PITAC will be considered as final.
9. Procuring agency reserves the right to increase or decrease the quantity of items to be procured.
10. The bidders should be on active taxpayers list of FBR. Valid copies of Company Registration, Income Tax and Sales Tax Registration Certificates will be attached.
